# ANINDILYAKWA LAND COUNCIL and EXECUTIVE DIRECTOR OF TOWNSHIP LEASING

#### TRAVEL RESTRICTIONS FOR GROOTE EYLANDT AND BICKERTON ISLAND

Due to the current Covid-19 outbreak in the Northern Territory, a number of travel restrictions are in place for those wishing to enter or travel through Groote Eylandt and Bickerton Island.

Anyone located within the Darwin lockdown area, as designated by the Northern Territory Government's Chief Health Officer (CHO), is prohibited from leaving this area until 1pm on 2 July 2021 unless advised otherwise by the CHO. Travelling to Groote Eylandt or Bickerton Island from this area is therefore prohibited.

Travel to these areas is also prohibited for anyone located within other lockdown areas or Covid-19 hotspots as designated by the CHO until such a time as that designation is removed.

Any essential workers (as defined by the Northern Territory Government) wishing to travel to Groote Eylandt or Bickerton Island from a designated lockdown area or hotspot are advised to contact the Northern Territory Government's Coronavirus Lockdown Advice Hotline at **1800 193 111** to ensure they meet the essential worker requirements and have obtained the relevant paper work prior to travelling.

Groote Eylandt and Bickerton Island residents who are currently in the designated lockdown area and unable to return home during this period are advised to contact Yilli Rreung Housing Aboriginal Corporation on (08) 8935 0100 or Larrakia Nation on 1800 PATROL.

Please re-consider your need to travel to Aboriginal Land during this time. Protecting our community remains the responsibility of everyone, and we ask that you respect the wishes of our Aboriginal communities during this difficult period.
